Farmer's Yield Initiative (FYI)

Farmers' Yield Initiative (FYI) is an educational messaging program made up of a coalition of public and private partners with the goal of raising public awareness about the benefits of the legal seed trade.

"Investment in crop research is essential to the future viability of the seed industry. Beginning in 2006, the "Farmers' Yield Initiative' of "FYI" informative campaign has the collective goal of advancing wheat research, education, seed certification, and the enforcement of intellectual property rights under the Plant Variety Protection Act (PVP) and patent laws."

The program uses direct mailing to communicate their educational message to producers in the Pacific Northwest. In 2016, over 1,750 growers in Idaho, Oregon, and Washington received the information. The goal is to broadcast a unified message as to the federal laws governing the seed industry. Producers are reminded about the benefits associated with using certified seed, and how buying legal seed is essential to funding and perpetuating agricultural progress. FYI also maintains a database of all producers who receive notice of the law, which is useful when a producer intentionally violates seed laws, yet claims to be unaware of protected varieties of seed.

The Idaho Medal of Achievement was created by Executive Order in 2015 to recognize citizens demonstrating exceptional, meritorious and inspirational service to the people of Idaho. It is intended for those who go above and beyond what is expected of them as citizens of Idaho. Honorees receive a 99.9-percent solid silver medallion meant as a lasting tribute to their civic virtue.

I was privileged to award the first Idaho Medal of Achievement on January 9, 2017, to pioneering teacherastronaut Barbara Morgan, whose commitment to education has extended from McCall, Idaho, into space, influencing and inspiring generations of Idahoans.

I encourage you to nominate noteworthy individuals for the 2017 award to be presented in January 2018. The Idaho Medal of Achievement is awarded annually to individuals – living or dead – who are nominated by the public and considered by a four-member Idaho Medal of Achievement Commission.

Revised Certification Standard

Rapeseed/Canola/Mustard

The Idaho State Legislature recently approved a revision to the Rapeseed/Canola/Mustard seed standards. The new standard replaces a zero tolerance for Sclerotinia bodies with a 1/50 grams tolerance. This change aligns ICIA standards with Canadian standards and should help facilitate seed movement between Idaho and Canadian provinces. The revised rule becomes effective at the close of the 2017 legislative session.

- 1 None means none found during normal inspection procedures.
- **2** Objectionable weed seeds are defined as: Restricted noxious plus *Brassica* species other than crop being inspected, and *Galium aparine* (Bedstraw).
- **3** Erucic acid and glucosinolate content must be within tolerances as described by the plant breeder for each variety.
- **4** All seed lots for which certification is applied shall be assayed for virulent Phoma lingam/Leptosphaeria maculans (Blackleg) and shown to be 99.99% free of this seed borne fungi.
